

TERMS & CONDITIONS FOR PARTICIPATION IN MARATHON 2024

1. PURPOSE AND GOALS

- 1.1. To promote a healthy, fit and active lifestyle, involving TSI students and staff, uniting representatives of the university and increasing the sense of community.
- 1.2. To provide an opportunity for TSI representatives to participate in the Rimi Riga Marathon 2024.
- 1.3. To determine and to provide TSI representatives an opportunity to take part in two running distances: DPD mile (1,609m) and 5km.

2. EVENT TIME FRAME

- 2.1. The Rimi Riga Marathon will take place on May 19, 2024, in Riga, Latvia.

3. PARTICIPANTS

- 3.1. Any TSI student and representative of the TSI academic or administrative staff can apply and participate (no age limit).
- 3.2. TSI provides only mentioned: registration, participant number receiving and visual presentation of the team's overall image. For coming to the marathon, the participant takes full responsibility himself.
- 3.3. TSI encourages you to objectively evaluate your abilities, strength and health before participating in the marathon.**

4. APPLICATION AND REGISTRATION

- 4.1. You can register for the marathon on the TSI website www.tsi.lv.
- 4.2. Registration for participation in the marathon opens on November 14, 2023.
- 4.3. The registration is open until December 17, 2023, 23:59.
- 4.4. When registering for the marathon, the following data must be provided: name, surname; date, month and year of birth; country; selected distance.
- 4.5. When registering, the participant confirms that he/she will participate in the marathon distance race on May 19, 2024.

5. PARTICIPATION FEE

- 5.1. The participation fee, in the above-mentioned distances, is covered by TSI.
- 5.2. In case a participant cancels his participation in the marathon, a written application must be submitted to the Study Department, stating a valid reason.
- 5.3. TSI event organizers reserve the right to evaluate the reason for the refusal, after which an invoice may be issued to cover the cost of the participant's registration fee.
- 5.4. If the cancellation is received after 27.03.2024, the participant must reimburse all actual costs related to his participation in this event.
- 5.5. The participant confirms that he/she is familiar with the terms of participation and agrees to cover the actual costs in case of unjustified cancellation.**



6. SAFETY TERMS

6.1. Each participant, upon receiving the race number, confirms with his signature that he/she takes full responsibility for the state of his health for the selected distance and will comply with the rules and regulations of the competition.

6.2. TSI organizers are not responsible for possible injuries of participants during the competition.

7. DISQUALIFICATIONS

7.1. The organizers have the right to disqualify the participant if he does not observe the norms of public order and comes to the event under the influence of intoxicating substances. In such a case, the participant shall cover all related actual costs for participating in the marathon.

8. PROTECTION OF PERSONAL DATA AND OTHER CONDITIONS

8.1. By registering for the marathon, the participant agrees to the processing of his personal data based on the General Data Protection Regulation (GDPR).

9. PHOTOS AND VIDEOS

9.1. Photography and filming is possible and planned during the event.

9.2. For marketing and advertising purposes, the organizers have the right to use the photos and video materials taken without an approval from the participants shown in the photos and video materials.

10. ADDITIONAL INFORMATION

10.1. By registering, the participant confirms that he/she has read and agrees to the Terms and Conditions of Participation, especially ones related to the health and safety of the participants, as well as participation cancellation.
